Preface

This Companion Guide to the v5010 ASC X12N Implementation Guides and associated errata adopted under HIPAA clarifies and specifies the data content when exchanging electronically with Zelis. Transmissions based on this companion guide, used in tandem with the v5010 ASC X12N Implementation Guides, are compliant with both ASC X12 syntax and those guides. This Companion Guide is intended to convey information that is within the framework of the ASC X12N Implementation Guides adopted for use under HIPAA. The Companion Guide is not intended to convey information that in any way exceeds the requirements or usages of data expressed in the Implementation Guides.

1.0 Introduction

This document describes the submission format of X12 5010 835 transactions from Zelis. It is meant to be used as a supplement to the standard X12N/005010X221 Technical Report. Where Zelis specific mapping requirements apply to or further constrain the mapping rules outlined in the technical report, a table will in the following format will be provided:

1.1 Scope

The scope of this document covers Zelis specific mapping requirements that apply to or further constrain those laid out in the standard X12N/005010X221 technical report, as well as the business use cases that Zelis can support.

Standard X12 mapping rules, formats, and content requirements are not in the scope of this document, rather the way in which Zelis has formatted it X12 mappings for submission to its clients.

1.2 Overview

This Companion Guide is meant to provide you with a written description of the X12 835 transaction set mappings that can be received by Zelis for successful processing.

1.3 References

This document is a companion to the ASC X12N Implementation Guide (005010X221) Health Care Claim Payment/Advice (835).

2.0 Getting Started

2.1 Working with Zelis

Zelis provides post-adjudication services for payers, providers, and networks. Zelis trading partners are Zelis clients and affiliates of Zelis clients.

The process for establishing an electronic connection with Zelis is as follows:

- 1. Initial contact made with Zelis requesting electronic connectivity.
- 2. Introduction conference call to communicate general information, desired workflow, and next steps.
- 3. Trading partner agreement and/or services contract.
- 4. Electronic connectivity setup (e.g. SFTP or interfaces).
- 5. Iterative testing.
- 6. Coordination of production processing.

Zelis support resources will be assigned and accessible during the implementation, testing, and production phases of the trading partner relationship.

2.2 Trading Partner Registration

2.3 System Availability and Downtime

Generally, data may be submitted to Zelis 24 hours a day, 7 days a week. However, to allow for system maintenance, Zelis may schedule downtime at various intervals, as needed.

3.0 Testing with Zelis

Testing with Zelis is done within the Zelis test environment, an environment separate from our production environment to ensure no crossover or process interference.

The general process for testing new electronic connections with Zelis is as follows:

- 1. Establishment of testing credentials and/or FTP subdirectories.
- 2. Verification of connection to the FTP server.
- 3. Submission of initial volume of test data for structural testing with associated iterative defect feedback.
- 4. Submission of initial volume of scenario test data with associated iterative defect feedback.
- 5. Trading partner testing sign-off.
- 6. Migration to production.
- 7. Agreement on production live date.
- 8. Updating test URLs to production URLs.
- Performing technical production monitoring for 1 to 2 weeks after first transactions are sent/received.

4.0 Connectivity with Zelis / Communications

4.1 Process Flows

Zelis provider trading partners may connect to their clearinghouse to receive both batch and real-time transactions. Providers may also contact Zelis servers directly to receive transactions via several methods:

- SFTP (FTP over SSH tunnel)
- FTPS (FTP with SSL extensions)
- Secure Email
- Secure Download
- Fax

Zelis specializes in custom process flows and, as such, no specific flow can be described in this document. Process flows will vary depending on the client or desired workflow of the trading partner, and will be agreed on during the introduction call described in section 2.1.



4.2 Transmission Administrative Procedures

Zelis file processing schedules for submissions vary based on when the connection was established, the applicable workflow and/or client. For example, files may be picked up or sent once per day, every hour, or every 20 minutes, depending on the workflow design.

Below are the Capacity and Frequency Restrictions and Rules of Behavior when interacting with Zelis systems and services.

4.3 Re-Transmission Procedure

For the 835-transaction set, Zelis will resubmit transactions as necessary without any technical complication from Zelis (Up to three months from the original sent date).

4.4 Communication Protocol Specifications

Zelis does not use custom electronic communications protocols. Please refer to section 4.1 for a list of the standard communications protocols Zelis uses.

4.5 Passwords

Zelis uses an internal, integrated security framework. As such, login names and passwords are used and required for ALL trading partner connections. Please note that this requirement stands even if additional authentication mechanisms are being used (e.g. X.509 certificate authentication).

Zelis assigns strong trading partner passwords, and passwords may not be updated by any outside user of the system.

Zelis does not store plaintext passwords, only encrypted passwords. As such, we are unable to retrieve a lost password.

If a password should be lost, Zelis must be contacted to have the password reset. Please note that any password reset request is subject to identify verification and administrative authorization.



5.0 Contact Information

5.1 EDI Client Service

Trading partners will receive a custom support e-mail and contact that is specific to their workflow. Contact information for the EDI team can be found at section 2.2.

5.2 EDI Technical Assistance

Trading partners will receive a custom support e-mail and contact that is specific to their workflow. If you need to reach the EDI team, they can be reached by the information in <u>section 2.2</u>.

5.3 Provider Service Number

Zelis is not a healthcare payer and does not perform claim adjudication, provider contracting, or credentialing. This information must be obtained from the relevant payer.

6.0 Control Segments & Envelopes

6.1 ISA Interchange

Zelis sends only one X12 envelope to be submitted per file. That is, only one ISA segment at the beginning of the file, and one IEA segment at the end of the file.

The following table describes the expected values to be submitted in the X12 interchange header and trailer control structures.

Values in bold represent exact, hard-coded values that must be submitted. No other values will be accepted.

Values in italics represent variable data that will depend on the envelope, implementation, or trading partner relationship.

6.2 GS Functional Group

For batch submissions, Zelis allows one or more functional groups to be submitted. However, each functional group must use an identical GS08 Industry Identifier Code.

For real-time submissions, Zelis allows only one functional group to be submitted.

The following table describes the expected values to be submitted in the X12 interchange header and trailer control structures.

Values in bold, represent exact hard-coded values.

Values in italics, represent variable data that will depend on the envelope, implementation, or trading partner relationship.

6.3 Transaction Sets

For batch submissions, Zelis allows one or more transaction sets to be submitted within a functional group. For real-time submissions, Zelis allows only one transaction set to be submitted for one or more functional groups. Process flows will vary depending on the client or desired workflow of the trading partner, and will be agreed on during the introduction call described in section 2.1.

7.0 Zelis Specific Business Rules and Limitations

There are no Zelis specific business rules or limitations defined for the 835-transaction set now. All mappings that are compliant with the X12N/005010X221 or X12N/005010X221A1 technical reports will be accepted and successfully processed by Zelis.

Zelis does require a trading partner agreement to establish an electronic interface for the exchange of 835 transactions.
